CAST Professional Certification for Super Operators (CPC)

Customers who are certified on CAST Application Intelligence Platform (CAST AIP) have increased software quality and achieved a quantum leap advance in productivity



Overview

The CAST Certification program recognizes demonstrated competence in leading and directing software analysis and measurement using CAST AIP. This certification program is for CAST **AIP Super Operator**, which is an expert role who has a thorough understanding of AIP and technologies for which AIP is being used for, and knowledge of related configuration in AIP.

A Minimum passing mark of **75%** for the entire certification is required to achieve the certificate. A maximum of **2 attempts** of the test over a period of two months is permitted. Thereafter the assessment will have to be purchased again.

Prerequisites

The pre-requisites to take up Professional Certification are:

- Completion of AIP Super Operator 101 Working with AIP through Console and AIP Super Operator 102 Hands-on Exercise (eLearning courses)
- Gain hands-on analysis and implementation experience for AIP through Console.
- Having knowledge of CAST AIP at an intermediate level. The incumbent should have reached the expected level of learning before attempting the Certification exam
- Having knowledge of latest release of AIP (release notes available at doc.castsoftware.com)

Certification Details and Guidelines

The duration for entire certification is **95 minutes** (1 hour 35 minutes). The certification is divided into two parts to test you on -

• **Technology Competency** - The section tests you on generic questions based on your preference or selection of technology. Such as, Java, .NET, Mainframe, or SAP. For this exam, you need to complete **20 questions** in **20 minutes**.

Note - While opting for the certification, you need to inform your preference or choice of technology for this to your CAST Representative.

• **AIP Competency** - The section tests you on various concepts of AIP on various areas such as AIP Platform and its configurations, Function Point Analysis Process, Transaction management, Extension management, and so on. For this exam **75 minutes** are permitted to complete **75 questions**.

Exam Scoring

The minimum passing mark for each section is 75%. The overall certification grading will be calculated based on the passing mark of both the sections.

After the timer starts for each section, it cannot be stopped even if you leave the test page. You can however return to an active test until that timer ends. Hence, it is recommended to attempt the certification only when you can dedicate the time required for complete the certification.
